Statutes; Standards; Holdings

Americans with Disabilities Act (ADA); ADA Amendments Act of 2008; Rehabilitation Act of 1972; Canton v. Harris; Use-of-Force Amendment-Based Standards; etc.

Definitions & Examples:

Key terms (e.g., disability; special needs; wheelchair; special needs; special needs population; visible & invisible disabilities; connected medical equipment; reasonable accommodations; HIPAA); etc.

Disability & Society

History; perceptions; tolerance; accountability; etc.

Wheelchair

History; categories; models (>100); use environments (e.g., personal; commercial; snow, sand, ice, escalator, elevator); nomenclature; propulsion methods; etc.

CONTROL: Wheelchair & User

Wheelchair user pat down & searching methods; prosthetics (identification, inspection, removal, & searching methods); physically managing a special needs wheelchair user and force options; wheelchair searching methods; contraband collection and management; canes; etc..

RESTRAIN: Wheelchair & User

Connected medical equipment issues and concerns; managing the obese or large stature wheelchair user; restraining the special needs wheelchair user; minimizing and/or avoiding restraint injuries; etc.

TRANSPORT: Wheelchair & User

Transferring from wheelchair to ambulance, patrol car, special transport vehicle, bus, etc.; strategies for when the wheelchair user must remain in the wheelchair; etc.

SKILLS DEVELOPMENT

Wheelchair propulsion methods; searching; restraining; transferring; teaching; etc.

USER-LEVEL PROGRAM

Review of evidence-based User-level training program; creating learner psychological & behavioral engagement; need for competency-based assessment(s); aligning training content with agency policy and procedure; etc.
